# Cremation Contract

## 1. Contract Statement

This Contract gives You, as the person named in this Contract, the right to receive the cremation service from Castlebrook Memorial Park.

Your Funeral Director (who will act as Our Authorised Agent) will complete this Contract, in conjunction with other regulatory paperwork, with You for the cremation service You are requesting which includes specific details required by Us to confirm and provide the service.

In this Contract these defined terms have the following meanings:

**Applicant (or You or Your):** The person who buys cremation services, and the person being the cremation applicant for the purpose of the *Public Health Regulation 2022*.

**Authorised Agent:** The Funeral Director authorised to act on behalf of the Operator.

**Cremation:** A process for reducing bodily remains.

**Crematorium:** A building where deceased persons are cremated.

**NSNA:** No Service No Attendance

**Operator's register:** A register kept by a cemetery or crematorium operator, in line with *Section 63 of the Cemeteries and Crematoria Act 2013 (NSW)*.

We will invoice Your Funeral Director for the cremation services you choose with us. Your Funeral Director will include the final price to be charged by us in this contract. Note, this price may vary due to, but not limited to, a change of day or extension of time.

## 6. Privacy and Collection of Information

The personal information collected in this Contract is collected and used to allow Us to provide the services to You. We manage the collection and use of this personal information in accordance with our privacy policy and privacy legislation. We may need to share it with other regulatory authorities, if the law requires Us to do so. For further information, please refer to Our Privacy Policy located at [www.mymemorial.com.au](http://www.mymemorial.com.au).

We will use the contact details set out in the Contract, or the updated contact details You have given us, to contact You. Please make sure that We have correct and up-to-date details (including contact details) for You and the person to be cremated which is necessary for Us to provide the cremation services. Please contact Us if you wish to check, update or correct any of the personal information You have provided.

## 7. Cremated Remains

In accordance with *NSW Public Health Regulations 2022*, We have the right to dispose of cremated remains if these are not collected within a reasonable time and must provide You with 14 days’ notice of disposal.

We hold cremated remains for up to 12 months for collection. During this time, we encourage You to contact our Memorial Park to discuss your memorialisation options.

## 8. Consumer Protection, Disputes and Complaints

We will follow all relevant laws in providing You with the services included in this Contract. This includes complying with Australian Consumer Law, Australian privacy law, work health and safety law, the *Cemeteries and Crematoria NSW Act*, and public health laws.

If You are not satisfied with the resolution of a complaint You can refer to Our Feedback Management Policy (available on [mymemorial.com.au](http://mymemorial.com.au)) on the dispute resolution process available to You. If a dispute arises in relation to any matter regarding the services or this Contract, We will follow the dispute resolution process set out in that policy.

The laws of New South Wales govern this Contract. If You or the Operator are unhappy with the dispute resolution outcome and the complaint is taken to court, You and the Operator agree to the jurisdiction of the courts of New South Wales.

- f) You understand that this Contract does not list prices charged by the Funeral Director. Invoicing for the cremation service will be issued by Your Funeral Director.
